Public Hearing and Possible Work Session

HB 2603

(1:05 pm) Requires owners or operators of undersea fiber optic telecommunication cables to obtain financial assurances and create plan for removal of cable.

Work Session

HB 2398

(1:20 pm) Requires Director of Department of Consumer and Business Services to ensure that statewide Reach Code mandates achievement of not more than 90 percent of site energy use that other statewide residential and commercial building codes require.

HB 3269

(1:40 pm) Directs Department of Environmental Quality to study and develop strategies to fund department's emergency response program.

HB 2143 **

**Subsequent Referral(s) to Ways and Means

(1:55 pm) Changes annual fees for all power claimants to match annual fees for other hydroelectric projects.

HB 2241

(2:10 pm) Requires Department of Environmental Quality to approve at least three businesses to provide water quality permit application review services.

HB 3375 **

**Subsequent Referral(s) to Ways and Means

(2:30 pm) Establishes goal of planning for development of three gigawatts of commercial scale floating offshore wind energy projects within federal waters off Oregon Coast by 2030.

Note Change: HB 2021 and HB 3180 were removed. HB 2603, HB 2398, HB 2143, HB 2241, and HB 3375 were added.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
