HB 2021
(1:15 pm) Directs Public Utility Commission to study laws related to clean energy and provide results to interim committees of Legislative Assembly no later than September 15, 2022.
HB 2190 ** **Subsequent Referral(s) to Ways and Means
(1:45 pm) Directs State Department of Energy to convene work group to develop program awarding grants for community energy resilience projects and implement program no later than January 1, 2023.

HB 2490

(2:00 pm) Authorizes Public Utility Commission to consider differential energy burden and other inequities of affordability in rates.

Public Hearing

HB 2688 **

**Subsequent Referral(s) to Ways and Means

(2:15 pm) Requires Department of Transportation to establish pilot program to assess how products that department or contractor for department procures affect emissions of carbon dioxide.

HB 3027

(2:30 pm) Prohibits certain products that use or contain hydrofluorocarbons from entering into commerce in Oregon if product was manufactured after specified date.

Note Change: HB 2488 and HB 2520 were removed. HB 3269 and HB 2190 were added.

You will see a confirmation screen and be sent an email with information on how to join the meeting. If you do not, contact the committee assistant.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
