Public Hearing and Work Session

- HB 2190 ** **Subsequent Referral(s) to Ways and Means
Directs State Department of Energy to convene work group to develop program awarding grants for community energy resilience projects and implement program no later than January 1, 2023.
- HB 2490
Authorizes Public Utility Commission to consider differential energy burden and other inequities of affordability in rates.

Work Session

- HB 3180
Modifies and adds laws related to utilities.
- HB 3269
Directs Department of Environmental Quality to study and develop strategies to fund department's emergency response program.

AGENDA (cont.) April 12, 2021

HB 3278

Directs State Department of Fish and Wildlife, in consultation with Department of State Lands and State Parks and Recreation Department, to study potential for developing commercial seaweed production to produce feed for livestock as means to reduce methane emissions.

HB 3375 **

**Subsequent Referral(s) to Ways and Means

Establishes goal of planning for development of three gigawatts of commercial scale floating offshore wind energy projects within federal waters off Oregon Coast by 2030.

HB 2143 **

**Subsequent Referral(s) to Ways and Means

Changes annual fees for all power claimants to match annual fees for other hydroelectric projects.

HB 2814

Directs Environmental Quality Commission to establish and implement indirect source review program.

HB 2021

Directs Public Utility Commission to study laws related to clean energy and provide results to interim committees of Legislative Assembly no later than September 15, 2022.

HB 2495

Revises provisions relating to chemicals in children's products.

HB 2398

Requires Director of Department of Consumer and Business Services to ensure that statewide Reach Code mandates achievement of not more than 90 percent of site energy use that other statewide residential and commercial building codes require.

HB 3372

Authorizes Department of Environmental Quality to designate person as chronic violator of environmental quality laws.

HB 2488 **

**Subsequent Referral(s) to Ways and Means

Requires Land Conservation and Development Commission to make changes to statewide land use planning goals by December 31, 2026, to address climate justice by addressing climate change adaptation and mitigation and environmental justice for disadvantaged communities.

HB 2520

Requires Land Conservation and Development Commission to amend statewide land use planning goals related to energy conservation to incorporate development of renewable energy facilities and reduction of greenhouse gas emissions and to match state energy policies.

Note Change: HB 2814 was changed to a work session.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.
