Work Session

HB 2190 ** **Subsequent Referral(s) to Ways and Means
Directs State Department of Energy to convene work group to develop program awarding grants for community energy resilience projects and implement program no later than January 1, 2023.

Public Hearing and Possible Work Session

HB 2241
Requires Department of Environmental Quality to approve at least three businesses to provide water quality permit application review services.

Work Session

HB 2490
Authorizes Public Utility Commission to consider differential energy burden and other inequities of affordability in rates.

HB 2688 ** **Subsequent Referral(s) to Ways and Means
Requires Department of Transportation to establish pilot program to assess how products that department or contractor for department procures affect emissions of carbon dioxide.

April 12, 2021

HB 3027

Prohibits certain products that use or contain hydrofluorocarbons from entering into commerce in Oregon if product was manufactured after specified date.

Public Hearing and Possible Work Session

HB 3106

Provides that, for purposes of electric companies' planning and pursuit of energy efficiency resources, energy efficiency programs include programs for assisting retail electricity consumers with replacing building heating, appliances and other technologies powered by any energy source with higher-efficiency electric heating, appliances and other technologies.

Work Session

HB 3180

Modifies and adds laws related to utilities.

HB 3269

Directs Department of Environmental Quality to study and develop strategies to fund department's emergency response program.

HB 3278

Directs State Department of Fish and Wildlife, in consultation with Department of State Lands and State Parks and Recreation Department, to study potential for developing commercial seaweed production to produce feed for livestock as means to reduce methane emissions.

HB 3375 **

**Subsequent Referral(s) to Ways and Means

Establishes goal of planning for development of three gigawatts of commercial scale floating offshore wind energy projects within federal waters off Oregon Coast by 2030.

HB 2143 **

**Subsequent Referral(s) to Ways and Means

Changes annual fees for all power claimants to match annual fees for other hydroelectric projects.

Public Hearing and Possible Work Session

HB 2814

Directs Environmental Quality Commission to establish and implement indirect source review program.

Work Session

HB 2021

Directs Public Utility Commission to study laws related to clean energy and provide results to interim committees of Legislative Assembly no later than September 15, 2022.

HB 2495

Revises provisions relating to chemicals in children's products.

HB 2398

Requires Director of Department of Consumer and Business Services to ensure that statewide Reach Code mandates achievement of not more than 90 percent of site energy use that other statewide residential and commercial building codes require.

HB 3372

Authorizes Department of Environmental Quality to designate person as chronic violator of environmental quality laws.

HB 2488 **

**Subsequent Referral(s) to Ways and Means

Requires Land Conservation and Development Commission to make changes to statewide land use planning goals by December 31, 2026, to address climate justice by addressing climate change adaptation and mitigation and environmental justice for disadvantaged communities.

AGENDA (cont.)

April 12, 2021

HB 2520

Requires Land Conservation and Development Commission to amend statewide land use planning goals related to energy conservation to incorporate development of renewable energy facilities and reduction of greenhouse gas emissions and to match state energy policies.

Note Change: HB 2603, HB 2657, HB 2660, HB 3181, and HB 2535 were removed. HB 2021, HB 2495, HB 2398, HB 3372, HB 2488 and HB 2520 were added.
