- HB 2301 ** **Subsequent Referral(s) to Ways and Means
(9:05am) Directs State Treasurer to develop and implement small business support loan program that aids in supporting economic activities of small businesses during times in which small businesses cannot conduct business activities at ordinary or customary level because of statewide or regional emergency or other significant disruption of business activity.
- HB 2869
(9:25am) Directs Oregon Business Development Department to conduct study regarding cost savings and expense reductions that may result to small businesses from cooperative resource sharing.
