- HB 2345 \*\* \*\*Subsequent Referral(s) to Ways and Means  
(8:45am) Requires Oregon Business Development Department to distribute moneys in Oregon Rural Capacity Fund to Oregon's Economic Development Districts for purpose of assisting rural jurisdictions to apply for and administer grants and other forms of funding available from any source.
- HB 2355 \*\* \*\*Subsequent Referral(s) to Ways and Means  
(8:50am) Requires Oregon Business Development Department to develop matching grant program to fund new positions in tribal governments to increase tribal capacity for economic development activities.
- HB 2518 \*\* \*\*Subsequent Referral(s) to Ways and Means  
(8:55am) Establishes program to make forgivable loans to reimburse private owner or operator of brownfield for eligible costs incurred in completion of removal or remedial action at brownfield.
- HB 2665 \*\* \*\*Subsequent Referral(s) to Ways and Means  
(9:00am) Allocates \$1,600,000 of lottery revenue to Oregon Business Development Department to be used to issue grants or loans in support of redevelopment of Port of Port Orford Cannery.
- HB 2820 \*\* \*\*Subsequent Referral(s) to Ways and Means  
(9:10am) Establishes Prosperity 1,000 Pilot Program to provide career coaching, occupational training and job placement services for at least 1,000 low-income job seekers residing in areas of concentrated poverty.
- HB 3010  
(9:15am) Requires media production companies seeking reimbursement under Oregon Production Investment Fund programs to perform certain actions related to diversity, equity and inclusion with respect to production for which reimbursement is sought.
- HB 3256  
(9:30am) Directs Public Utility Commission to study laws related to telecommunications and provide results to interim committees of Legislative Assembly no later than September 15, 2022.
