HB 3376 ** **Subsequent Referral(s) to Ways and Means
(8:05am) Directs Oregon Business Development Department to develop and implement program to award grants to operators of movie theaters closed to public due to public health restrictions related to COVID-19.

Work Session

HB 2267 ** **Subsequent Referral(s) to Ways and Means
(8:30am) Provides that fixed percentage of certain forecasted video lottery revenues be transferred to counties for economic development.

HB 2518 ** **Subsequent Referral(s) to Ways and Means
(8:40am) Establishes program to make forgivable loans to reimburse private owner or operator of brownfield for eligible costs incurred in completion of removal or remedial action at brownfield.

- HB 2665 ** **Subsequent Referral(s) to Ways and Means
(8:50am) Allocates \$1,600,000 of lottery revenue to Oregon Business Development Department to be used to issue grants or loans in support of redevelopment of Port of Port Orford Cannery.
- HB 2701 ** **Subsequent Referral(s) to Housing then to Ways and Means
(9:00am) Establishes Rural System Development Charges Program within Housing and Community Services Department to pay system development charges for rural affordable multifamily housing.
- HB 2820 ** **Subsequent Referral(s) to Ways and Means
(9:10am) Establishes Prosperity 1,000 Pilot Program to provide career coaching, occupational training and job placement services for at least 1,000 low-income job seekers residing in areas of concentrated poverty.
- HB 3010
(9:20am) Requires media production companies seeking reimbursement under Oregon Production Investment Fund programs to perform certain actions related to diversity, equity and inclusion with respect to production for which reimbursement is sought.
- HB 3256
(9:30am) Directs Public Utility Commission to study laws related to telecommunications and provide results to interim committees of Legislative Assembly no later than September 15, 2022.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
