- HB 3177 ** **Subsequent Referral(s) to Rules
(8:05am) Limits types of restrictions that Governor may impose on certain businesses during state of emergency related to COVID-19 pandemic.
- HB 2173 ** **Subsequent Referral(s) to Revenue
(8:15am) Provides that lottery revenues dedicated to county economic development purposes may be transferred to Oregon Department of Administrative Services to pay for portion of costs of regional solutions coordinators within Regional Solutions Program.
- HB 2282
(8:25am) Requires Department of Land Conservation and Development to approve City of Bend's expansion of urban growth boundary, and allows department to approve other land use regulations for city on specified lands, if owner of land possesses development opportunity transferred from Metolius resort site owner and city meets other conditions.
- HB 2334
(8:35am) Modifies provisions relating to statement of cost of compliance effect on small businesses required as part of agency rulemaking.

HB 3040

(8:45am) Directs Legislative Revenue Officer to study system development charges and report findings to interim committees related to local government.

HB 2701 **

**Subsequent Referral(s) to Housing then to Ways and Means

(8:55am) Establishes Rural System Development Charges Program within Housing and Community Services Department to pay system development charges for rural affordable multifamily housing.

HB 2266

(9:05am) Directs Oregon Business Development Department to study use of economic development methods for purpose of assisting businesses and to report its findings to interim committees of Legislative Assembly related to business on or before September 15, 2022.

Please note: SB 846 A is scheduled solely for the purpose of referral to a different committee without recommendation.

SB 846 A

(9:15am) Modifies method for calculating amount transferred from Administrative Services Economic Development Fund to Employer Incentive Fund.
