#### **Public Hearing**

HB 3307

(3:20 pm) Clarifies that intergovernmental entity may seek to obtain any benefits from any public or private entity that any unit of local government or American Indian tribe that is party to intergovernmental agreement may seek to obtain.

#### **Work Session**

HB 3245

(3:30 pm) Authorizes eligible business to deliver malt beverages, wine or cider to final consumer through use of delivery person.

HB 3000

(3:40 pm) Directs Oregon Liquor Control Commission to study cannabis.

HB 3013

(3:50 pm) Directs Oregon Liquor Control Commission to study regulation of cannabis.

- HB 3194 \*\* \*\*Subsequent Referral(s) to Revenue then to Ways and Means  
(4:00 pm) Allows licensee, permittee or certificate holder authorized to import, export, sell, distribute, ship or deliver wine to import, export, sell, distribute, ship or deliver low-proof spirit beverages on same terms.
- HB 3239  
(4:10 pm) Establishes limits on where cannabis may be processed.
- HB 3344  
(4:20 pm) Specifies that required deposit to Oregon Liquor Control Commission of moneys from retail sale of distilled liquor by appointed agent is determined by retail sales in cash.
- HB 2156  
(4:30 pm) Grants Attorney General comprehensive authority to procure or supervise procurement of goods, services and personal services related to programs under Attorney General's authority.
- HB 3369 \*\* \*\*Subsequent Referral(s) to Ways and Means  
(4:40 pm) Requires transfer of moneys from Oregon Marijuana Account to Oregon Health Authority for purposes of administering Oregon Medical Marijuana Program.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

*Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.*

**Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.**
