Public Hearing

SB 742 A

(3:20 pm) Limits local government regulations on certain nonresidential alarm systems and battery-charged fences.

Work Session

SB 317 A

(3:40 pm) Allows holder of full on-premises sales license to make retail sales of mixed drinks and single servings of wine in sealed containers for off-premises consumption.

SB 406 A

(3:50 pm) Allows holder of direct shipment permit to ship up to five cases of wine, each containing not more than nine liters, per month to Oregon resident.

SB 299 A

(4:00 pm) Authorizes formation of children's service districts.

SB 750

(4:10 pm) Authorizes Oregon Liquor Control Commission to grant temporary letter of authority to eligible applicant for any license issued by commission.

SB 165 A** **Subsequent Referral(s) to Rules (4:20 pm) Establishes annual payments to be made by race meet operators that conduct mutuel wagering on horse races previously held.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.</
