Public Hearing

SB 424

(3:20 pm) Allows base pay of attorneys who are employed by public corporation, nonprofit organization, public university or city or county in this state and who perform substantially similar work to be used for comparison of compensation for assistant attorneys general.

SB 307

(3:30 pm) Waives fees for obtaining medical marijuana card for veterans who have total disability rating of at least 50 percent as result of injury or illness incurred or aggravated during active military service, and who received discharge or release under other than dishonorable conditions.

SB 636 A

(3:40 pm) Provides that when state agency is required by statute to mail certain notice to individual, and agency has on file post office box address for individual, agency must mail notice to post office box address if address is individual's last known address on file or address to which individual has requested that notices be sent.

(3:50 pm) Limits local government regulations on certain nonresidential alarm systems and battery-charged fences.

SB 317 A

SB 299 A

(4:10 pm) Authorizes formation of children's service districts.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
