Public Hearing

HB 2081

(3:15 pm) Modifies Health Care Cost Growth Target Program and Health Care Cost Growth Target Implementation Committee.

HB 3108

(3:45 pm) Requires individual and group health insurance policies, health care service contractors, multiple employer welfare arrangements and state medical assistance program to provide reimbursement for at least three primary care visits annually.

HB 2541

(4:15 pm) Provides that licensed optometrist may perform specified ophthalmic surgery procedures.

Oral Testimony (Live Remotely)
