#### Work Session

HB 2622

Requires hospitals and ambulatory surgical centers to use smoke evacuation system during surgical procedures likely to generate surgical smoke.

HB 2362

Requires health care entities to obtain approval from Oregon Health Authority before any mergers, acquisitions or affiliations of entities that had \$25 million or more in net patient revenue in preceding three fiscal years or before mergers, acquisitions or affiliations that will result in one entity having increase in net patient revenue of \$1 million or more.

HB 3036

Removes requirement that physician assistant practice under supervising physician.

- HB 2359  
Requires health care providers to work with health care interpreters from health care interpreter registry operated by Oregon Health Authority to provide interpretation services.
- HB 2044  
Allows Department of Consumer and Business Services to access data in All Payer All Claims database by certifying data will only be used to carry out department's duties.
- HB 3030  
Authorizes licensed optometrist to prescribe and administer vaccines and epinephrine and diphenhydramine injections.
- HB 2462  
Requires pharmacy benefit manager to amend contract with pharmacy or pharmacy services administrative organization or take other steps to adjust reimbursement paid to pharmacy or pharmacy services administrative organization to take into account costs incurred from new taxes or fees.
- HB 2508  
Requires Oregon Health Authority to ensure reimbursement of health services delivered using telemedicine.
- HB 2528  
Directs Oregon Board of Dentistry to issue dental therapist license to qualified applicant.
- HB 2910 \*\*  
Requires Oregon Health Authority, upon receipt of federal approval, to assess fee on emergency medical services providers and use fee to reimburse costs of emergency medical services transports. \*\*Subsequent Referral(s) to Ways and Means
- HB 2261  
Prohibits remote sales of inhalant delivery systems.
- HB 2965  
Extends deadline for local plans for applying foundational capabilities and implementing foundational programs related to public health to December 31, 2025.
- HB 2072 \*\*  
Increases fees for licenses for home health agencies. \*\*Subsequent Referral(s) to Ways and Means
- HB 2627  
Allows expanded practice dental hygienist to perform interim therapeutic restoration.

HB 2591 \*\*

CARRIED OVER FROM THE 3-18-2021 MEETING: Allows mobile school-based health centers to qualify for safety net grants from Oregon Health Authority.

HB 2464

CARRIED OVER FROM THE 3-18-2021 MEETING: Allows person employed by health care facility to practice surgical technology if person is enrolled in or has completed specified apprenticeship program.

HB 2623

Limits cost-sharing for health benefit plan coverage of insulin prescribed for treatment of diabetes.

HB 2958

Allows pharmacist to prescribe and dispense preexposure prophylactic antiretroviral drug to patient after completion of patient assessment.

HB 2376

Requires health care provider who prescribes opioid to offer prescription for naloxone, or similar drug, and educational material under specified circumstances.

***Note change: HB 3030, HB 2462, HB 2508, HB 2528, HB 2910, HB 2261, HB 2965, HB 2072 and HB 2627 have been added.***
