Public Hearing

SB 219 A

(3:30 pm) Directs Advance Directive Adoption Committee to submit report to interim committees of Legislative Assembly related to judiciary and health with recommendations for development, adoption and administration of statewide advance directive registry for collection and dissemination of advance directives.

SB 764 A

(3:50 pm) Provides that court must presume that resolution agreement that ends dispute over alleged infringement of patent or violation of other protection for protected drug has anticompetitive effects if alleged infringer receives item of value as part of or in connection with resolution agreement or if alleged infringer agrees to limit or stop researching, developing, manufacturing, marketing or selling competing drug.

SB 748 A

(4:15 pm) Requires Public Employees' Benefit Board, Oregon Educators Benefit Board and private insurers to provide insurance coverage to adult disabled children of insureds under certain circumstances.

Work Session

SB 64 A

Creates exemption to prohibition on person under 21 years of age entering establishment where tobacco products or inhalant delivery systems are sold for purposes of investigating violations.

SB 711 A

Requires Department of Consumer and Business Services to study cost differences in hormone replacement drugs used by men and hormone replacement drugs used by women and report findings to Legislative Assembly no later than September 15, 2022.

SB 699

Prohibits grandfathered health plan from imposing preexisting condition exclusion.

SB 781 A

Modifies provisions relating to providing results of tests to patients.

SB 741

Repeals sunset on and obsolete reporting requirement for Central Oregon Health Council.

Written testimony may be submitted up to 24 hours after the meeting start time.

Register to testify live remotely:

- Registration is required to testify by phone or video.

You will see a confirmation screen and be sent an email with information on how to join the meeting. If you do not, contact the committee assistant.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
