HB 2951

(8:05 AM) Prohibits association or other owners from retaliating or discriminating against owner for exercising owner's right.

HB 2534

(8:20 AM) Requires homeowners associations and condominium associations to review governing documents and remove discriminatory language on or before December 31, 2023.

HB 2409

(8:35 AM) Prohibits homeowners associations from requiring application of pesticide on owner's property.

HB 2283

(8:55 AM) Allows land division to separate dwelling units for new middle housing allowed in cities.
