HB 2595

(3:40 PM) Appropriates moneys from General Fund to Department of Human Services for allocation to area agencies to address unmet needs of seniors for mental and behavioral health treatment and to address disproportionate burdens on seniors arising from COVID-19 pandemic.

HB 2964 **

(4:00 PM) Requires Department of Human Services to reimburse cost of care provided in residential training facilities and residential training homes in amounts sufficient to allow facilities and homes to pay direct support professional 150 percent of state minimum wage.
