Possible Introduction of Committee Measures

#### Public Hearing

HB 2825

(1:10 pm) Requires sentencing court to consider as mitigation evidence defendant was subjected to domestic abuse that was significant factor in criminal behavior.

HB 2823

(1:35 pm) Removes kidnapping in the first degree and kidnapping in the second degree from definition of "sex crime" that triggers obligation to report as sex offender.

HB 2942 \*\*

\*\*Subsequent Referral(s) to Education

(2:00 pm) Removes certain nonviolent crimes from list of crimes that automatically make person ineligible to hold license or registration issued by Teacher Standards and Practices Commission if person has been convicted of crime.

#### **Work Session**

HB 2199

Requires local correctional facility to contact primary health care provider of pretrial detainee within 72 hours of booking and ensure that detainee receives health care prescribed by provider.

HB 2201

Requires local correctional facility to provide to veteran who is in pretrial detention health care recommended by United States Department of Veterans Affairs Veterans Health Administration.

HB 2545

Directs court to appoint counsel at state expense in certain domestic relations proceedings involving children.

HB 2547

Directs State Court Administrator to study methods for assigning single judge to domestic relations cases to serve throughout duration of case.
