Public Hearing

HB 2399

(1:00 - 1:20 pm) Permits employers to seek issuance of restraining order or stalking protective order on behalf of employee when certain conditions are met.

HB 2586

(1:20-1:50 pm) Creates process for obtaining restraining order against person who is not family or household member for actions that cause bodily injury or fear of imminent bodily injury.

HB 2746

(1:50-2:15 pm) Directs State Court Administer to develop and implement Hope Card Program for issuance of information cards to persons who are protected by restraining orders.

HB 2747

(2:15-2:45 pm) Modifies start date for calculating one-year duration of certain protective orders if court continues or modifies order more than 30 days after original order date.
