Public Hearing

HB 3077

(1:00-1:25 pm) Removes requirement that person seeking intervention in juvenile dependency proceeding or rights of limited participation in juvenile dependency or delinquency proceeding prove that existing parties cannot adequately present case.

HB 3115

(1:25-2:15 pm) Provides that local law regulating sitting, lying, sleeping or keeping warm and dry outdoors on public property that is open to public must be objectively reasonable as to time, place and manner with regards to persons experiencing homelessness.

HB 3035

(2:15-2:30 pm) Directs Department of Corrections and local correctional facilities to assess and address health care needs of persons in custody upon intake.

HB 2200 **

**Subsequent Referral(s) to Ways and Means

(2:30-2:45 pm) Requires local correctional facility to contact primary health care provider of pretrial detainee within 72 hours of booking and ensure that detainee receives health care
