HB 3115

(1:05-1:50 pm) Provides that local law regulating sitting, lying, sleeping or keeping warm and dry outdoors on public property that is open to public must be objectively reasonable as to time, place and manner with regards to persons experiencing homelessness.

HB 2367

(1:50-2:15 pm) Establishes Oregon Right to Rest Act.

HB 3035

(2:15-2:30 pm) Directs Department of Corrections and local correctional facilities to assess and address health care needs of persons in custody upon intake.
