Public Hearing

HB 3115

(1:05 - 1:15 pm) Provides that local law regulating sitting, lying, sleeping or keeping warm and dry outdoors on public property that is open to public must be objectively reasonable as to time, place and manner with regards to persons experiencing homelessness.

HB 2825

(1:15 - 1:45 pm) Requires sentencing court to consider as mitigation evidence defendant was subjected to domestic abuse that was significant factor in criminal behavior.

HB 3035

(1:45 - 1:55 pm) Directs Department of Corrections and local correctional facilities to assess and address health care needs of persons in custody upon intake.

HB 3112 ** **Subsequent Referral(s) to Ways and Means
(1:55 - 2:10 pm) Establishes Cannabis Equity Board within office of Governor to provide equity oversight of cannabis industry in this state.

Work Session

HB 2986
Requires Board on Public Safety Standards and Training to ensure that police officers and certified reserve officers are trained to investigate, identify and report crimes motivated by prejudice based on perceived gender of victim.

HB 3115
Provides that local law regulating sitting, lying, sleeping or keeping warm and dry outdoors on public property that is open to public must be objectively reasonable as to time, place and manner with regards to persons experiencing homelessness.

Please note: The following bills are scheduled solely for the purpose of committee discussion:

HB 2935
Limits authority of school district to become member of voluntary organization that administers interscholastic activities unless organization implements policy that prohibits discrimination based on race, color or national origin.

HB 3041
Removes "gender identity" from definition of "sexual orientation" in ORS 174.100 and creates standalone definition of "gender identity" in ORS 174.100.

HB 3164
Modifies crime of interfering with a peace officer or parole and probation officer.

Note change: HB 2297 public hearing removed. Agenda re-ordered and times adjusted.

- Registration closes at the time the meeting is scheduled to begin.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature’s website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
