## Work Session

HB 2543

Prohibits transfer of firearm by gun dealer or private party if Department of State Police is unable to determine whether recipient is qualified to receive firearm.

HB 2746

Directs State Court Administer to develop and implement Hope Card Program for issuance of information cards to persons who are protected by restraining orders.

HB 2939

Declares venue of juvenile proceeding subject to waiver hearing to be county where alleged act was committed.

HB 2940

Creates exception to 28-day time limit for detention of youth if request for waiver hearing is pending.

#### HB 3035

Directs Department of Corrections and local correctional facilities to assess and address health care needs of persons in custody upon intake.

#### HB 3273

Prohibits law enforcement agency from releasing booking photo except in specified circumstances.

#### HJR 5

#### Please note: HJR 5 is scheduled solely for the purpose of referral to the House Committee on Rules without recommendation.

Proposes amendment to Oregon Constitution to repeal provision requiring inmates in corrections institutions to engage in full-time work or on-the-job training.

#### **Recommended from the House Judiciary Subcommittee on Civil Law:**

#### HB 2459

Includes in definition of "conversation" communication occurring through video conferencing program for purposes of statutes regulating recording of communications.

HB 2547

Directs State Court Administrator to study methods for assigning single judge to domestic relations cases to serve throughout duration of case.

#### HB 2571

Directs Department of Consumer and Business Services, in consultation with State Forestry Department, Oregon State University and Oregon Prescribed Fire Council, to study liability for prescribed fires.

HB 2935

Limits authority of school district to become member of voluntary organization that administers interscholastic activities unless organization implements policy that prohibits discrimination based on race, color or national origin.

HB 3041

Removes "gender identity" from definition of "sexual orientation" in ORS 174.100 and creates standalone definition of "gender identity" in ORS 174.100.

## Recommended from the House Judiciary Subcommittee on Equitable Policing:

HB 2513

Requires police officers to be trained in airway and circulatory anatomy and physiology and certified in cardiopulmonary resuscitation.

HB 3047

Establishes civil cause of action for improper disclosure of personal information.

HB 3182

(2:00 - 2:25 pm) Directs Department of Human Services to study and make recommendations on provisions of state law relating to adoption of Indian children.

HB 3230 \*\*

\*\*Subsequent Referral(s) to Ways and Means (2:25 - 2:45 pm) Establishes universal representation program in Oregon Department of Administrative Services.

#### Work Session

HB 3355

Specifies identification required on uniforms of law enforcement officers working in crowd management.

#### **Recommended from the House Judiciary Subcommittee on Equitable Policing:** HB 2575

Directs Department of Justice to establish program for awarding grants to law enforcement agencies and local governments for training of groups and agencies that interact with persons who have experienced trauma.

HB 2928

Regulates use of chemical incapacitants, kinetic impact projectiles and sound devices by law enforcement agencies.
