Public Hearing

HB 3182

(1:05 - 1:35 pm) Directs Department of Human Services to study and make recommendations on provisions of state law relating to adoption of Indian children.

HJR 5

(1:35 - 1:50 pm) Proposes amendment to Oregon Constitution to repeal provision requiring inmates in corrections institutions to engage in full-time work or on-the-job training.

Work Session

HB 2459

Includes in definition of "conversation" communication occurring through video conferencing program for purposes of statutes regulating recording of communications.

HB 2571

Directs Department of Consumer and Business Services, in consultation with State Forestry Department, Oregon State University and Oregon Prescribed Fire Council, to study liability for prescribed fires.

HB 2935

Limits authority of school district to become member of voluntary organization that administers interscholastic activities unless organization implements policy that prohibits discrimination based on race, color or national origin.

HB 3041

Removes "gender identity" from definition of "sexual orientation" in ORS 174.100 and creates standalone definition of "gender identity" in ORS 174.100.

HB 3047

Establishes civil cause of action for improper disclosure of personal information.

HB 3273

Prohibits law enforcement agency from releasing booking photo except in specified circumstances.

Please note: The following bills are scheduled solely for the purpose of committee discussion:

HB 2575

Directs Department of Justice to establish program for awarding grants to law enforcement agencies and local governments for training of groups and agencies that interact with persons who have experienced trauma.

HB 2928

Regulates use of chemical incapacitants, kinetic impact projectiles and sound devices by law enforcement agencies.

HB 2932

Directs Oregon Criminal Justice Commission to establish statewide database of reports of use of physical force by peace officers and corrections officers.

HB 3059

Repeals statute authorizing law enforcement officers to command dispersal of unlawful assemblies and arrest participants who do not disperse.

HB 3164

Modifies crime of interfering with a peace officer or parole and probation officer.

HB 3355

Specifies identification required on uniforms of law enforcement officers working in crowd management.

- **Register by phone:** 833-588-4500 (U.S. toll free). You will be given a phone number to call into the meeting.
- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature’s website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
