#### Public Hearing

HB 3117

(1:05 - 1:20 pm) Prohibits prosecuting attorney from conditioning plea agreement on stipulation of defendant's ability to pay attorney fees for appointed counsel or other defense fees and expenses.

HB 2367

(1:20 - 1:35 pm) Establishes Oregon Right to Rest Act.

#### Work Session

HB 2162

Directs Department of Public Safety Standards and Training to study changes to police officer training and to provide results of study to Legislative Assembly no later than December 31, 2021.

HB 2172

Converts mandatory minimum sentences for specified felonies other than murder to presumptive sentences.

### **April 13, 2021**

HB 2239

Directs each judicial district to ensure veterans who are criminal defendants have access to veterans' court programs.

HB 2367

Establishes Oregon Right to Rest Act.

HB 2400

Provides that victim of sexual assault or domestic violence crime has right to obtain law enforcement records relating to crime.

HB 2418

Requires district attorney to, upon request, provide to sexual assault victim opportunity to review case file within district attorney's office.

HB 2825

Requires sentencing court to consider as mitigation evidence defendant was subjected to domestic abuse that was significant factor in criminal behavior.

HB 2929

Modifies police officer's duty to report misconduct.

HB 3005

Repeals statute creating state preemption of local firearm regulation and statutes creating exceptions to preemption.

HB 3117

Prohibits prosecuting attorney from conditioning plea agreement on stipulation of defendant's ability to pay attorney fees for appointed counsel or other defense fees and expenses.

HB 3134

Replaces references to vehicle accident and vehicle collision with vehicle crash.

HB 3136

Provides that person who operates motor vehicle upon premises open to public or highways of this state is deemed to have given consent to submit to drug recognition evaluation under certain circumstances.

HB 3140

Makes changes to statutes related to operating vehicle or boat while under influence of intoxicants that reference controlled substances to clarify applicability to psilocybin.

HB 3327 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Extends sunset for authorization to Department of Justice to assist victims of domestic violence and sexual assault with housing needs until January 2, 2024.

HB 3374

Provides that when court reduces felony conviction to Class A misdemeanor after person's completion of probation, person for purposes of law is deemed not to have been previously convicted of felony.

HJM 7

Urges Congress to pass legislation to allow access to specified federal health benefits and programs for pretrial detainees, by redefining term "inmates of a public institution" as used in federal Social Security Act.
