#### Public Hearing

SB 133 A

CARRIED OVER FROM THE 5/20/21 MEETING: Places limits on admissibility of facilitated dialogue and responsibility letter bank programs for youth offenders and persons temporarily assigned to youth correction facilities.

SB 134 A

CARRIED OVER FROM THE 5/20/21 MEETING: Creates exemption to disclosure of information or records regarding certain youth participating in Oregon Youth Authority programs or treatment.

SB 214 A

CARRIED OVER FROM THE 5/20/21 MEETING:

***Please note: SB 214 A is scheduled solely for the purpose of hearing testimony from those previously signed up to testify at the 5/20/21 meeting.***

Provides that certain evidence of economic damages creates rebuttable presumption of reasonableness for purposes of restitution ordered as part of criminal sentence.

SB 218 A

## AGENDA (cont.)

May 24, 2021

Expands types of charges eligible for conditional discharge to include any misdemeanor or Class C felony, other than driving while under the influence of intoxicants, if defendant has been formally accepted into specialty court.

SB 649

*Please note: SB 649 is scheduled solely for the purpose of hearing testimony from those previously signed up to testify at the 5/18/21 meeting.*

Increases penalties for criminal sexual contact with underage victim when defendant is victim's teacher.

SB 836 A

*Please note: SB 836 is scheduled solely for the purpose of hearing testimony from those previously signed up to testify at the 5/18/21 meeting.*

Directs Department of Corrections to consider all other alternatives before suspending or terminating alternative incarceration program in its entirety for more than five consecutive days.

### Work Session

SJM 2

Urges Congress to amend Thirteenth Amendment to United States Constitution to omit clause excepting criminal punishment, thereby ending racist legacy of slavery in nation's most important document.

SJM 4

Urges Congress to enact legislation to begin process of implementing reparations for African Americans based on slavery and discrimination.

SJR 10

Proposes amendment to Oregon Constitution to prohibit slavery and involuntary servitude in all circumstances.

SB 41 A

CARRIED OVER FROM THE 5/20/21 MEETING: Adds officer who is certified as parole and probation officer and is employed full-time by State Board of Parole and Post-Prison Supervision to definition of "parole and probation officer."

Declares emergency, effective on passage.

SB 116 A

CARRIED OVER FROM THE 5/20/21 MEETING: Provides that it is unlawful for private security provider or entity that employs private security providers to possess or use equipment, vehicles, uniforms or titles that imply affiliation with public or private safety agency.

SB 176

CARRIED OVER FROM THE 5/20/21 MEETING: Creates exceptions to certain privileges in abuse proceedings.

SB 177 A

CARRIED OVER FROM THE 5/20/21 MEETING: Provides that proponent of certain hearsay statements is not required to issue material witness order or seek sanctions for contempt in order to show unavailability of declarant.

SB 649

Increases penalties for criminal sexual contact with underage victim when defendant is victim's teacher.

### *Recommended from the House Judiciary Subcommittee on Civil Law:*

SB 181

Directs court to consider, in determining amount of award of attorney fees, whether attorney performed services on pro bono basis or award of attorney fees otherwise promotes access to justice.

SB 185 A

Specifies circumstances under which members of nonprofit corporation and board of directors of nonprofit corporation may discuss issues or take action by electronic means without meeting.

SB 190 A

Modifies permissible methods of providing notice of appointment of guardian to protected person.

SB 200 A

CARRIED OVER FROM THE 5/20/21 MEETING: Requires district attorney of each county to adopt written policies concerning guilty except for insanity dispositions.

SB 221

Modifies court procedure for determining whether decedent intended writing to be decedent's will, partial or complete revocation of decedent's will or addition to or alteration of decedent's will.

SB 295 A

Defines terms related to fitness to proceed.

SB 572

Modifies protective proceedings to permit vulnerable youth guardianships for adults between 18 and 21 years of age who are eligible for special immigrant status and who are unable to be reunified with parent due to abuse, neglect or abandonment that occurred before adult attained 18 years of age.

SB 578 A

Requires court, under certain circumstances, to appoint legal counsel for respondent or protected person in protective proceeding.

SB 753

CARRIED OVER FROM THE 5/20/21 MEETING: Repeals requirement that Division of Child Support provide certain spousal support enforcement services for obligees who receive public assistance but who are not also receiving child support enforcement services.

SB 768 A

Modifies provisions relating to attorneys.

SB 767

CARRIED OVER FROM THE 5/20/21 MEETING: Allows signature of judgment creditor or attorney signing satisfaction document to be notarized or accompanied by declaration under penalty of perjury.
