**Public Hearing**

HB 3164

(8:00 am - 9:00 am) Modifies crime of interfering with a peace officer or parole and probation officer.

**Work Session**

HB 2928

(9:00 am) Regulates use of chemical incapacitants, kinetic impact projectiles and sound devices by law enforcement agencies.

HB 2932

Directs Oregon Criminal Justice Commission to establish statewide database of reports of use of physical force by peace officers and corrections officers.

### **February 24, 2021**

HB 3145

Directs Department of Public Safety Standards and Training to establish publicly available database of certain information about misconduct and discipline of public safety employees established by department.

HB 3059

Repeals statute authorizing law enforcement officers to command dispersal of unlawful assemblies and arrest participants who do not disperse.

***Note change: HB 3164 Public Hearing added. HB 3059 Work Session added. HB 2481, HB 2986, HB 3047 Work Sessions removed.***
