Public Hearing

- HB 2226
(1:05 pm) Requires ballots returned by mail to be postmarked not later than date of election.
- HB 2687
(1:25 pm) Requires ballots returned by mail to be postmarked not later than date of election.
- HB 2679
(1:45 pm) Permits person who will be 17 years old on date of primary election and 18 years old on date of general election to vote at primary election for candidates of major political party with which person is affiliated if major political party has adopted rule to this effect.
- HJR 11
(2:20 pm) Proposes amendment to Oregon Constitution providing for same-day voter registration.

Oral Testimony (Live Remotely)
