#### Work Session

- HB 2174 \*\* \*\*Subsequent Referral(s) to Ways and Means  
(1:05 pm) Requires Oregon Department of Administrative Services, upon request of county governing body, to credit forest reserve moneys that would otherwise be credited to county road fund to certain public bodies whose service areas include entire county.
- HB 2992 \*\* \*\*Subsequent Referral(s) to Ways and Means  
(1:10 pm) Requires state boards or commissions to pay compensation and expenses to certain members with adjusted gross income below certain threshold.
- HB 2993  
(1:15 pm) Requires agency to appoint advisory committee to represent interests of persons likely to be affected by proposed rule.
- HB 3110  
(1:20 pm) Requires board of directors of publicly traded corporation to have specified proportion of female directors and directors who are members of underrepresented communities.

### Public Hearing

HB 2499

(1:30 pm) Extends automatic voter registration to Oregon Health Authority and any state agency designated by Governor.

HB 3291

(2:15 pm) Requires Secretary of State to conduct study and analyze best practices for financing electoral campaigns.

*Please note: HB 3291 is scheduled for the purpose of hearing the -1 amendment.*

### Work Session

HB 2681

(2:40 pm) Requires each county clerk to file annual report with Secretary of State identifying each voter who clerk moved to inactive status during previous calendar year and specifying reason for moving voter to inactive status.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

*Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.*

**Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.**
