Work Session

HB 2337

Requires state agencies and third party contractors that collect demographic data on behalf of state agencies to comply with rules adopted by Oregon Health Authority for collection of data on race, ethnicity, preferred spoken and written languages and disability status.

HB 3000 A

Defines "adult use cannabis item," "artificially derived cannabinoid" and "tetrahydrocannabinol" for statutes related to marijuana and industrial hemp.

SB 483 A

Creates rebuttable presumption that person violated prohibition against retaliation or discrimination against employee or prospective employee if person takes certain action against employee or prospective employee within 60 days after employee or prospective employee has engaged in certain protected activities.
