SB 5 A

(1:05 pm) Permits students participating in intercollegiate sports to earn compensation for use of name, image or likeness and to retain professional representation or athlete agent.

SB 319

(1:25 pm) Dedicates portion of State Capitol State Park to Vietnam War memorial to be funded and constructed by qualified nonprofit corporation.

SB 16

Allows counties to partition and rezone up to 200 acres of lands within Eastern Oregon Border Economic Development Region from exclusive farm use to residential uses.

SB 250 A

Provides that county clerk shall establish regular business hours of at least four hours per day, and 30 hours per week, Monday through Friday, for receipt and certification of instruments presented for recording.

SB 759

Directs Legislative Administrator to represent legislative department in collective bargaining negotiations with legislative department employee bargaining units.

SB 291 A

Requires landlords to adopt certain written screening criteria made available to applicants before accepting application.

SB 278

Amends calculation of maximum amount payable by Housing and Community Services Department to landlords from Rent Guarantee Program Fund from per-landlord basis to per-tenant basis.

HB 3394

Establishes State Gambling Task Force.

HB 3318

Exempts dog training facilities from state structural specialty codes.

You will see a confirmation screen and be sent an email with information on how to join the meeting. If you do not, contact the committee assistant.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
