HB 3367

(10:30 AM) Requires local governments to unconditionally allow restoration or replacement of certain uses destroyed by 2020 wildfires until December 31, 2025.

HB 3315

(10:35 AM) Directs Housing and Community Services Department to study issues relating to building in areas affected by wildfires and report to appropriate committee or interim committee of Legislative Assembly on or before September 15, 2022.

HB 2272

(10:40 AM) Directs Department of Land Conservation and Development to study issues relating to use of land and report to appropriate committee or interim committee of Legislative Assembly on or before September 15, 2022.
