(8:00 am) Requires Water Resources Department to establish grant program for purpose of sharing cost of remediating reductions in amount of ground water available for domestic personal use in Greater Harney Valley Groundwater Area of Concern due to overallocation of ground water for agricultural use.

HB 3166

(8:45 am) Requires Legislative Policy and Research Committee to study and make recommendations to interim committee of Legislative Assembly regarding water measurement program.

HB 2615

(9:15 am) Directs Water Resources Department to review water measurement data collection, retention, use and reporting and report to committee or interim committee of Legislative Assembly related to water on or before September 15, 2022.
