Public Hearing

HB 2954

Allows public charter school to implement weighted lottery that favors historically underserved students when number of applications for enrollment exceeds capacity of program, class, grade level or building.

HB 2969 A

Directs school districts to provide age-appropriate instruction in oral health as part of health education curriculum.

HB 3234 A

Requires school districts to provide instruction on organ and tissue donation and education.

HB 3183 A

Requires parents of child who is deaf or deafblind or who is hard of hearing to be provided information about relevant services and placements offered by school district, education service district, regional programs and Oregon School for the Deaf whenever individualized family service plan or individualized education program is developed, revised or reviewed.

Work Session

HB 2136

Clarifies terminology of persons who may be investigated or disciplined by Teacher Standards and Practices Commission.

HB 2536

Requires school or school district to offer lunches and breakfasts at no charge to student if school or school district meets requirements of special provisions of federal meal program or if student is from household with income that does not exceed 300 percent of federal poverty guidelines.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
