### **Public Hearing**

- SB 333 \*\* \*\*Subsequent Referral(s) to Finance and Revenue CARRIED OVER FROM THE 2-4-2021 MEETING: Directs Legislative Revenue Officer to conduct study related to renewable hydrogen and report results to interim committees of Legislative Assembly related to revenue no later than September 15, 2022.
- SB 16

Allows counties to partition and rezone up to 200 acres of lands within Eastern Oregon Border Economic Development Region from exclusive farm use to residential uses.

SB 286

Renames Environmental Justice Task Force as Environmental Justice Council.

SB 289

Directs office of Governor, in consultation with Racial Justice Council's Environmental Equity Committee, to study laws related to environment and provide results to interim committees of Legislative Assembly no later than September 15, 2022.
