Public Hearing

SB 864

Increases maximum percentage of tax that governing body of city or county may impose on sale of marijuana items.

SB 25

Increases amount of revenue from business registry filings that Secretary of State dedicates to operations of office of Secretary of State from \$20 per filing to \$25 per filing.

Note change: SB 25 Public Hearing and Possible Work Session was changed to a Public Hearing.
