#### Public Hearing

- SB 587 \*\* \*\*Subsequent Referral(s) to Finance and Revenue  
Requires Department of Revenue to issue license to qualified retailers of tobacco products and inhalant delivery systems.
- SB 748  
Requires Public Employees' Benefit Board, Oregon Educators Benefit Board and private insurers to provide insurance coverage to adult disabled children and adult disabled siblings of insureds under certain circumstances.
- SB 584  
Requires Oregon Health Authority to provide medical assistance to employed individuals with disabilities without regard to individuals' income or resources.
- SB 355  
Delays sunset of requirement that health insurance reimburse cost of applied behavior analysis for autism spectrum disorder.
- SB 358  
Changes authorization to practice for behavior analysis interventionists from registration to licensure.

#### Work Session

- SB 96  
Defines "cannabinoids" for purpose of inhalant delivery systems.

SJR 12

Proposes amendment to Oregon Constitution establishing obligation of state to ensure every resident of state access to cost-effective, clinically appropriate and affordable health care.

SB 428

Extends for one year sunset on Task Force on Universal Health Care and extends deadline for task force to submit recommendations to Legislative Assembly.
