Work Session

SB 307

Waives fees for obtaining medical marijuana card for veterans who have total disability rating of at least 50 percent as result of injury or illness incurred or aggravated during active military service, and who received discharge or release under other than dishonorable conditions.

SB 71

Directs Oregon Health Authority to study issues related to fitness to proceed and to provide results of study to Legislative Assembly no later than December 31, 2021.

Please note: SB 71 is scheduled solely for the purpose of referring to the Senate Committee on Rules without recommendation.

Public Hearing

SB 758

Changes "Oregon Medical Marijuana Act" to "Oregon Medical and Therapeutic Cannabis Act."
Allows person designated to produce marijuana by registry identification cardholder to enter into agreement with registry identification cardholder to transfer marijuana to another registry identification cardholder or primary caregiver.

March 24, 2021

SB 758 is scheduled for a public hearing solely for the purpose of hearing testimony from those who were unable to speak at the 3/17/2021 meeting.

SB 844

Establishes Prescription Drug Affordability Board in Department of Consumer and Business Services to review prices for prescription drug products meeting specified cost criteria.

SB 844 is scheduled for a public hearing solely for the purpose of hearing testimony from those who were unable to speak at the 3/22/2021 meeting.

SB 12

Requires benefit plans offered by Public Employees' Benefit Board and Oregon Educators Benefit Board to cover certain costs related to travel to Mexico or Canada to fill and refill prescriptions.

SB 700

Establishes Oregon Brain Injury Trust Fund Board to administer programs paid for by Oregon Brain Injury Trust Fund to provide service coordination and skills training to individuals with brain injuries, provide educational information to increase awareness and understanding of issues and needs related to brain injuries and to provide grants to support research into treatment of brain injuries.

SB 741

Repeals sunset on and obsolete reporting requirement for Central Oregon Health Council.

SB 719

Provides that certain aggregate data relating to reportable disease investigations are not confidential or exempt from disclosure under public records law unless data could reasonably lead to identification of individual.

SB 848

Establishes Office of Pharmaceutical Purchasing in Oregon Health Authority and specifies duties.

SB 629

Allows pharmacist to use telepharmacy to deliver pharmacy services to patient at remote location.

SB 157 **

**Subsequent Referral(s) to Tax Expenditures

Enacts express sunset for exemption of medical marijuana registry cardholder or primary caregiver from tax imposed on retail sale of marijuana items.
