SB 684

CARRIED OVER FROM THE 4/5/2021 AGENDA: Establishes Task Force on Oregon Medical Board.

Please note: The public hearing on SB 684 is scheduled solely for the purpose of committee discussion.

Work Session

SB 699

Prohibits grandfathered health plan from imposing preexisting condition exclusion.

SB 781

Modifies provisions relating to providing results of tests to patients.

SB 772

Requires individual and group health insurance policies to reimburse services provided by naturopathic physicians within scope of their practice if services are reimbursed when provided by licensed physicians.

SB 674

Requires Oregon Health Authority to investigate best practices and latest technology and to establish hospital procedures to enable family members to visit hospitalized patients during pandemic.

AGENDA (cont.) April 7, 2021

SB 705

CARRIED OVER FROM THE 4/5/2021 AGENDA: Adds two members who are physician assistants or retired physician assistants to membership of Oregon Medical Board.

SB 168

CARRIED OVER FROM THE 4/5/2021 AGENDA: Requires health benefit plans to cover fertility and reproductive endocrinology services.

SB 800

CARRIED OVER FROM THE 4/5/2021 AGENDA: Requires Oregon Health Authority to study and make recommendations to interim committees of Legislative Assembly, no later than September 15, 2022, for legislative changes needed to increase access to health care for all Oregonians.

SB 763

CARRIED OVER FROM THE 4/5/2021 AGENDA: Provides that person may not engage in business as pharmaceutical representative without obtaining license from Director of Department of Consumer and Business Services.

SB 764

CARRIED OVER FROM THE 4/5/2021 AGENDA: Provides that Attorney General and court must presume that resolution agreement that ends dispute over alleged infringement of patent or violation of other protection for protected drug has anticompetitive effects if alleged infringer receives item of value as part of or in connection with resolution agreement or if alleged infringer agrees to limit or stop researching, developing, manufacturing, marketing or selling competing drug.

SB 844

CARRIED OVER FROM THE 4/5/2021 AGENDA: Establishes Prescription Drug Affordability Board in Department of Consumer and Business Services to review prices for prescription drug products meeting specified cost criteria.

SB 848

CARRIED OVER FROM THE 4/5/2021 AGENDA: Establishes Office of Pharmaceutical Purchasing in Oregon Health Authority and specifies duties.

SB 157 **

******Subsequent Referral(s) to Tax Expenditures

CARRIED OVER FROM THE 4/5/2021 AGENDA: Enacts express sunset for exemption of medical marijuana registry cardholder or primary caregiver from tax imposed on retail sale of marijuana items.

SB 719

CARRIED OVER FROM THE 4/5/2021 AGENDA: Provides that certain aggregate data relating to reportable disease investigations are not confidential or exempt from disclosure under public records law unless data could reasonably lead to identification of individual.

SB 758

CARRIED OVER FROM THE 4/5/2021 AGENDA: Changes "Oregon Medical Marijuana Act" to "Oregon Medical and Therapeutic Cannabis Act." Allows person designated to produce marijuana by registry identification cardholder to enter into agreement with registry identification cardholder to transfer marijuana to another registry identification cardholder or primary caregiver.

Note change: SB 684, SB 705, SB 168, SB 800, SB 763, SB 764, SB 844, SB 848, SB 157, SB 719, and SB 758 have been added.
