Public Hearing

HB 2622 A
Requires hospitals and ambulatory surgical centers to use smoke evacuation system during surgical procedures likely to generate surgical smoke.

Work Session

HB 2046 A
CARRIED OVER FROM THE 5/17/2021 AGENDA: Requires insurer to provide specified notice to insured or prospective insured enrolled in short term health insurance policy.

HB 2648
CARRIED OVER FROM THE 5/17/2021 AGENDA: Allows pharmacist or pharmacy technician to transfer drug containing pseudoephedrine without prescription to person who is at least 18 years of age and presents person's valid government-issued photo identification.

HB 2528 A
Directs Oregon Board of Dentistry to issue dental therapist license to qualified applicant.

HB 2970 A
Defines "device" for purposes of practice of advanced nonablative esthetics.

HB 2574 A

Clarifies permissibility of disposition of human bodies by alternative authorized processes including alkaline hydrolysis and natural organic reduction.

HB 2958 A

Allows pharmacist to prescribe , dispense and administer preexposure prophylactic antiretroviral therapies and post-exposure prophylactic antiretroviral therapies.

HB 3036 A

Allows physician assistant to register with Oregon Medical Board for authority to dispense prescription drugs.

Note change: HB 2046 A and HB 2648 have been added.

Written testimony may be submitted up to 24 hours after the meeting start time.

Register to testify live remotely:

- Registration is required to testify by phone or video.

You will see a confirmation screen and be sent an email with information on how to join the meeting. If you do not, contact the committee assistant.
 - **Register by phone:** 833-588-4500 (U.S. toll free). You will be given a phone number to call into the meeting.
- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature’s website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
