Public Hearing

SB 291

Directs office of the Governor, in consultation with Racial Justice Council's Housing and Homelessness Committee, to study laws related to housing and to provide results to interim committees of Legislative Assembly no later than September 15, 2022.

SB 79

Authorizes Housing and Community Services Department to provide grants and loans to individuals for down payment assistance and grants, loans and technical assistance to organizations increasing homeownership program access to persons of color.
