Public Hearing and Possible Work Session

SB 282
Directs Housing and Community Services Department to study issues related to rental housing and report to appropriate committee or interim committee of Legislative Assembly on or before September 15, 2022.

Work Session

SB 148 ** **Subsequent Referral(s) to Tax Expenditures
Extends sunset for tax credit for individual development account donations.
SB 82 ** **Subsequent Referral(s) to Finance and Revenue
Establishes Individual Development Account Fund.
SB 622 ** **Subsequent Referral(s) to Ways and Means
Authorizes issuance of \$10 million in lottery bonds for deposit in Levee Project Grant Fund to be used to provide grants for levee projects.

Register to testify live remotely:

- Registration is required to testify by phone or video.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.
