Work Session

- SB 67
Requires Oregon Health Authority, in collaboration with specified stakeholder groups, to identify, assess and prepare report on regulatory and policy barriers to effective and timely behavioral health treatment for individuals with co-occurring disorders.
- SB 69
Expands range of housing for individuals with substance use disorders that is authorized to receive development funding from Oregon Health Authority.
- SB 698
Requires Oregon Health Authority to adopt rules requiring opioid treatment center, as condition for approval to operate in this state, to accept Medicare payments as reimbursement for cost of services provided by center.
- SB 718 **
Appropriates moneys from General Fund to Department of Human Services to award grants to refugee resettlement agencies to provide specified services to refugees. ****Subsequent Referral(s) to Ways and Means**
- SB 686
Establishes right to receive inpatient psychiatric care in person and on-site.

SB 721

Modifies charge to and member appointment process for Consumer Advisory Council that assists and advises Director of Oregon Health Authority on mental health and substance use disorder services.

SB 680

Provides funding to peer-run organizations in Portland metropolitan area, southern Oregon region and eastern and central Oregon region to operate peer respite centers to provide peer respite services to individuals with mental illness who experience acute distress, anxiety or emotional pain.
