Work Session

- HB 2102 A
Requires Department of Human Services to report to interim committees of Legislative Assembly related to human services , by December 31, 2022, comprehensive proposal for department staffing that meets specified criteria.
- HB 2104 A
Modifies definition of "current caretaker."
- HB 2155
Modifies definition of "public or private official" for purposes of mandatory child abuse reporting.
- HB 2333 A
Directs Department of Human Services to report information regarding prescription of psychotropic medications to children in foster care.
- HB 3026
Directs Department of Transportation to waive fee for issuing, renewing or replacing identification card if person who is issued card is experiencing homelessness.

Register to testify live remotely:

You will see a confirmation screen and be sent an email with information on how to join the meeting. If you do not, contact the committee assistant.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.
