#### Public Hearing

SB 201

CARRIED OVER FROM THE 2/1/2021 MEETING: Provides that person commits offense of driving while under influence of intoxicants if person has blood alcohol level of 0.08 percent or more by weight within two hours after driving vehicle.

SB 214

CARRIED OVER FROM THE 2/1/2021 MEETING: Expands definition of "victim," for purposes of restitution ordered as part of criminal sentence, to include person or entity that has expended moneys on behalf of, or provided services to, minor victim.

## **AGENDA (cont.) February 2, 2021**

SB 217

CARRIED OVER FROM THE 2/1/2021 MEETING: Defines "statutory counterpart" for purposes of Oregon Criminal Code and Oregon Vehicle Code.

SB 218

CARRIED OVER FROM THE 2/1/2021 MEETING: Expands types of charges eligible for conditional discharge to include any misdemeanor or Class C felony if defendant has been accepted into specialty court.

SB 422

Eliminates fees and court costs associated with juvenile delinquency matters.

SB 448

Prohibits permanent rule from being in effect for longer than six years.

SB 636

Provides that when state agency is required by statute to mail notice to person, and agency has on file post office box address for person, agency must mail notice to post office box address.

***Note change: Public hearings on SB 201, SB 214, SB 217, and SB 218 have been carried over from the 2/1/2021 agenda. There will be no new testimony on carried over agenda items outside of those invited.***
