### Public Hearing

SB 424

Allows base pay of attorneys who are employed by public corporation, nonprofit organization, public university or city or county in this state and who perform substantially similar work to be used for comparison of compensation for assistant attorneys general.

SB 666

Modifies public meeting notice requirements for meetings held in executive session.

SB 819

Establishes procedure by which district attorney and incarcerated person may jointly petition sentencing court for reconsideration of conviction and sentence.

SB 579

Directs Oregon Public Guardian and Conservator to develop and administer a community restoration program for providing guardianship services to defendants who are unable to aid and assist in their defense and who will be released into community.

SB 820

Removes exception from regulation by Sexual Offense Treatment Board for certain persons.

#### **Work Session**

SB 54

Updates terminology for Youth Development Council to match changes in federal law.

SB 571

Allows persons convicted of felony to register to vote, update voter registration and vote in elections while incarcerated.

SB 752

CARRIED OVER FROM THE 3/30/21 AGENDA: Provides that defendant's reasonable belief that victim consented constitutes affirmative defense in certain prosecutions for sexual abuse in the second degree and sexual abuse in the third degree.

SB 768

CARRIED OVER FROM THE 3/30/21 AGENDA: Modifies provisions relating to attorneys.

SJM 2

Urges Congress to amend Thirteenth Amendment to United States Constitution to omit clause excepting criminal punishment, thereby ending racist legacy of slavery in nation's most important document.

SJM 4

Urges Congress to enact legislation to begin process of implementing reparations for African Americans based on slavery and discrimination.

SJR 10

Proposes amendment to Oregon Constitution to prohibit slavery and involuntary servitude in all circumstances.

SB 755

CARRIED OVER FROM THE 3/30/21 AGENDA: Makes form and style changes to provisions in Ballot Measure 110 (2020).
