Requires certain persons that service student loans in this state to obtain or renew license.

SB 426

Allows telecommunicators to purchase certain retirement credits and increased benefits under Public Employees Retirement System.

SB 500

Establishes Public Records Advocate as independent office.

SB 315

Exempts from required disclosure business, commercial, financial, operational and research data and information that is furnished, developed or generated in connection with ownership or operation of unmanned aerial system test range, if disclosure of information would cause competitive disadvantage to test range or users.
