Public Hearing

SB 28

Prohibits person from disseminating advertisement to business entity that falsely states, implies, represents or suggests that, or otherwise causes reasonable confusion or reasonable false belief as to whether, person is part of, affiliated with, sponsored by, associated with or acting on behalf of governmental entity or governmental entity approves, authorizes or endorses person or offer or goods or services in advertisement.

Public Hearing and Possible Work Session

SB 420

Permits local contract review board or local contracting agency to enact or adopt, as appropriate, ordinance, resolution, rule, regulation or other legislative or administrative measure to designate certain public improvement contracts as community benefit contracts.

SB 577

Specifies contract price at which apprentice utilization requirements apply to qualified contracts with institutions of higher education and school districts.

April 1, 2021

SB 746

Makes unlawful practice for place of public accommodation to refuse to accept United States coins or currency as payment for goods and services.

SB 716

Requires employers to reasonably accommodate employee's work schedule availability related to child care.

You will see a confirmation screen and be sent an email with information on how to join the meeting. If you do not, contact the committee assistant.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
