Work Session

SB 420

Permits local contract review board or local contracting agency to enact or adopt, as appropriate, ordinance, resolution, rule, regulation or other legislative or administrative measure to designate certain public improvement contracts as community benefit contracts.

SB 716

Requires employers to reasonably accommodate employee's work schedule availability related to child care.

Public Hearing and Possible Work Session

SB 172

Requires Director of Employment Department to study unemployment insurance benefits and to report findings to interim committees of Legislative Assembly related to employment on or before September 15, 2022.

SB 402

Allows hemp grower or handler to sell or transfer hemp cuttings.

SB 408

Allows marijuana producer to track by batch mature marijuana plants.

SB 489

Removes restriction on authorization of retroactive temporary disability compensation.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
