#### **Public Hearing and Possible Work Session**

HB 2221 A

Imposes requirements on state agency that employs person at rate higher than rate for executives under compensation plan for state employees.

#### **Work Session**

HB 2111

Changes name of "Oregon Liquor Control Commission" to "Oregon Liquor and Cannabis Commission." Declares emergency, effective August 2, 2021.

HB 2818 A

Allows payment from Wage Security Fund to be made to wage claimant for wages earned and unpaid in event that Commissioner of Bureau of Labor and Industries has obtained judgment in action or has issued final order in administrative proceeding for collection of wage claim.
