#### Public Hearing

SB 762

Directs Legislative Policy and Research Office to study strategies to promote wildfire response and recovery and report to appropriate committee or interim committee of Legislative Assembly on or before September 15, 2022.

#### Possible Work Session

SB 642 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Appropriates moneys from General Fund to State Department of Agriculture for deposit in Wolf Management Compensation and Proactive Trust Fund.

SB 832

Prohibits person, on or after effective date of Act, from breeding mink, transporting mink to or from mink farm or working at mink farm unless person has tested negative for COVID-19 within previous 10 days.

### Public Hearing

SB 828

Makes certain findings concerning effects of poor forest management.

SB 342

Directs State Department of Agriculture to study and make recommendations for pesticide regulation and provide results of study in report to interim committees of Legislative Assembly no later than September 15, 2022.

SB 344

Requires State Forestry Department to study and make recommendations to interim committee of Legislative Assembly regarding efficacy of prescribed burns.
